Funding of the Pearls Course and the Review Course through the JKOMSF began in 2014 when the course management and support was removed from LSU CDE. Revenue to cover expenses for Pearls courses is very close. Some years we are short a thousand or so and some years we have produced a small profit. It is difficult to make money with a short course given in a hotel in New Orleans. CDE and CME credit hours are usually 10 hours to allow alumni and friends tourist time. The total revenue from the Review Courses the past 2 years exceeded expenses by \$120,000. Registration fees from attendance over a 5-6 day period is much more profitable. Credit hours are over 40 hours.

Our speakers and their presentations are:

FRIDAY – APRIL 7, 2017

1. **Choosing Wisely: Third Molar Removal.** *James Swift, DDS*
This talk will review the radiographic signs associated with an increased risk of nerve injuries associated with third molar extractions. Also the appropriate use of cone beam CT imaging will be discussed.
2. **Coronectomy of Teeth: Options and Complications.** *Stuart Lieblich, DMD*
The clinical procedure for coronectomy procedures will be presented along with associated complications.
3. **Dynamic Image Navigation for Dental Implants — a Team Approach for Implementation.** *Robert W. Emery III, DDS*
Contemporary implant surgery includes the need to use some form of computer assisted surgery. Every Oral and Maxillofacial Surgeon and their team need to understand how the various forms of image guided surgery are implemented. A new "Optically Guided Surgical System" that utilizes visible light optical tracking will be presented in a concise and information packed format. Implementation of this new system will be reviewed: Image acquisition, Treatment planning, Patient and instrument registration and Surgery.

4. **Surgical Management of Impacted Teeth Other Than Third Molars**

Stuart Lieblich, DMD

The oral and maxillofacial surgeon is often called on to coordinate the management of impacted canines and second molars. This section will present clinical techniques for dealing with these impactions.

Dealing with patients on the various anti-resorptive medications has become an important part of the oral surgery practice.

Recent technological advancements in digital impressions allow for mainstream OMS usage. Digital impressions allow for improved implant placement accuracy, fabrication of custom temporary and permanent restorations and provide a powerful marketing tool to your patients and referrals.

7. **Non-Surgical Cosmetic Pearls to Augment Your Scope of Practice**

John P. Neary, DDS, MD, FACS

This lecture will provide a comprehensive review of the latest injectable fillers and their uses with additional discussion on the use of neurotoxins, lasers for resurfacing, and scar revision. The topics will be presented in a manner that will encourage practitioners to incorporate these procedures into their practice.

8. **Anesthesia Mishaps in the Oral Surgery Office. *James Swift, DDS***

The provision of ambulatory anesthesia is associated with known risks and complications. This talk will review the current state of the risks of anesthesia in the oral surgeon's office.

9. **Something Old, Something New: Geriatric and Pediatric Anesthesia**

Considerations. Stuart Lieblich, DMD

The challenge of providing an office anesthetic is different when dealing with the extremes of age. This section will discuss the significant differences in pharmacokinetics and physiologic issues in these populations.

10. **Anesthesia M&M. *James Swift, DDS and Stuart Lieblich, DMD***

Actual office anesthetic cases that occurred in the oral surgery office will be presented to illustrate the mistakes that were made and what warning signs and interventions might have caused a better outcome.
