

New Presidential Appointment

Please welcome newly appointed President of the JK OMS Foundation, **Tooley Towns**, **DDS**. Following Misiek's term, Towns will begin his endeavors to fulfill the mission of the foundation on July 1, 2010.

The Purpose of the TK OMS Foundation

Our Past

Base salaries for our faculty were nearly 100% hard state lines and 50-75% of a starting salary in private practice. There were six full-time faculty lines and sufficient time for research.

LSU OMS residents who trained prior to 1987 generously contributed \$600,000 over a four-year period to gain \$400,000 in matching state funds to form the James R. Peltier Chair. Over the years monies from this chair 1) funded most of our department research, 2) allowed faculty and residents to attend OMS meetings and present papers and 3) provided small contributions to faculty salaries when state portions of these salaries were taken from us. Much of the residency program, as many of you experienced, would not have occurred with out the Peltier Chair. 70% of the Peltier Chair donations ranged from \$5,000 to \$25,000, and \$10,000 donations were common.

That was 22 years ago.

Our Present

- 1. Over the past 22 years LSU funding through the state has substantially decreased. Our faculty base salary is primarily from hospital income and not hard state pay lines.
- 2. The base pay of full-time faculty is 30% or less than many of our recent resident's starting pay in private practice. That percentage decreases dramatically by the end of three years. Part-time faculty pay lines are almost unchanged since 1987.
- 3. During the past five years, several exceptional OMS, who wanted an academic career, were interviewed for our two vacant positions. They all declined and found opportunities in other institutions

or private practice because of the low salary structure.

- 4. With a skeleton staff, there is little or no time for faculty research.
- 5. Our faculty practice site at the school was lost with Katrina. There are plans for rebuilding by FEMA, but who knows when or what the final product will be.
- 6. Industry, mainly bone plate companies, use to donate significant funds annually for the sole purpose of resident education and travel. That source no longer exists as federal ethic laws prohibit these contributions.

Our Future

The LSU OMS Alumni Association, through the efforts of a core group of concerned alumni, has formed the JK OMS Foundation for the purpose of supporting the teaching, research and service goals of the LSU OMS department in New Orleans. The Foundation is a 501 C (3) organization and all donations are tax deductible. Now is the opportunity for all LSU OMS graduates to give a small fraction of their practice earning back to the site of their training. It is so true that all of us are forever appreciative of the opportunity to enjoy our profession and its financial rewards. I sincerely hope your appreciation can be expressed with a worthwhile contribution to the training program and the current and future residents in training. I know our residents want to experience the educational opportunities during training that you enjoyed. When they finish, they hope that this training will enable them to realize the satisfaction of professional and financial rewards that you have realized. —INK



- 1.A steering committee of your fellow graduates has been formed to assist in the board of directors fund raising campaign.
- 2. The campaign goal of the JK OMS Foundation is \$3.2 million for the next 4 years.
- 3. Your contributions may be designated to one or both funds -
 - (A) the Foundation Fund or (B) the Chair Fund.
 - (A) Foundation Fund: Monies contributed to the Foundation Fund are invested and controlled outside of the LSUHSC. Our goal is \$2 million. These monies will be used to support the training program at the complete discretion of the JK OMS Foundation.
 - (B) Chair Fund: Monies contributed to the Chair Fund will be sent to an LSUHSC Account so that a Chair application to the state can be made. A 40% contribution from the state will take our goal of \$1.2 million to \$2 million. These monies would be controlled by the department through the dental school.
- 4. The primary focus of the JK OMS Foundation is to have

LSU graduates complete a pledge. We encourage all to make an initial sizable contribution this year. \$10,000 contributions, for example, have already been received. This is one thirdmolar case every other month.

- 5. A secondary focus is for all of us to realize and seek out those friends, former patients, and others who may wish to donate large sums. This is why we have created two Funds within the JK OMS Foundation . Many of these donors would like their philanthropy associated with LSU, and we can give them this opportunity. There are also donors who might like to have the greater autonomy in monies controlled outside the school. These persons are out there. Please give thought to this part of the campaign.
- 6. I realize there are other OMS fund raising campaigns such as AAOMS Foundation, REAP, Walker, LSUSD Committee of 100 and others. These are all worthwhile and deserving campaigns, but let's face it, the JK OMS Foundation should be the heart and soul of all LSU OMS Trainees —JNK

and economic success well beyond that of the majority of our peers.
