



James R. Peltier, BS, DDS, FACD, FICD, PhD (Hon)

Alumnus of the Year, JKOMS Foundation and LSU OMS Alumni Association

r. James Peltier has enjoyed an outstanding a LSU Oral career as Maxillofacial Surgeon (OMS), a highly successful business leader, and a life time civic contributor to Thibodaux and Louisiana. His contributions to LSU, LSU OMS, and the state of Louisiana are remarkable and par excellence.

Jimmy always strived to achieve the very best for his patients, business associates, community and state organizations, and above all, love and support for LSU. In his youth this love was self-evident when, as an LSU student, he became responsible for the security of Mike the Tiger # 1. Mike, in his cage, was lost only once for a few hours in the Austin, Texas country side the night before an LSU football game at the U. of Texas. We don't know how those Longhorns stole him, but Jimmy found him. Today Mike does



not travel. He just enjoys his \$3 million habitat.

After his education at LSU, Loyola School of Dentistry, and OMS residency at Duke and Charity Hospital ('59), Jimmy served as an active staff member of local and regional hospitals and became Chief of the Medical Staff at St. Joseph's Hospital. He has numerous life memberships in dental and OMS organizations and served as President of the Bayou District Dental Association and the Southeastern Society of Oral and Maxillofacial Surgeons. He was elected to Omicron Delta Kappa national honorary dental fraternity. His OMS career is highlighted with 8 refereed publications and service aboard the hospital ship S. S. HOPE in Ceylon (Sri Lanka) for 2 months, 1968.

In Thibodeaux Jimmy quickly began volunteering and serving as a leader in many civic organizations. He was President of Rotary, Grand Marshall of the Fireman's Fair, President of the Chamber of Commerce, Chairman of the Lafourche Red Cross, and Secretary/Treasurer since 1963 of the Lafourche Association for Retarded Citizens. He has also served as President of the Council for a Better Louisiana, Board of Directors of the Louisiana Gulf Coast Conservation Association and was Chairman of the Board of Public Affairs Research Council. A proud moment in Jimmy's athletic career was serving as an Official Torch Bearer on the 1996 Olympic Relay Team. Yes, he carried the Olympic Torch through the streets of Thibodaux and the torch somehow made it to Atlanta.

Jimmy was a major contributor to LSU OMS and Health Sciences Center as an advisor on medical/dental education and scope of surgical procedures. In the late 70's, Jimmy helped me establish many of the procedures our OMS residents and practitioners enjoy today. I frequently observed Jimmy's council and sage advice to Deans and Chancellors on all aspects of the LSU Medical Centers mission. Jimmy became a member of the LSU Board of Supervisors and served as Chairman in 1980-81. His leadership skills were recognized and he became President of LSU Alumni Association, President of the LSU Foundation, served on the Board of Directors of the LSU Medical Center Foundation and the Louisiana State Museum Foundation, and was active in bringing several U. S. Presidents to LSU as Graduation Speakers. His relationship with Senator Russell Long led to passage of Medicare benefits for dentistry.

Jimmy was the guiding force behind the drive for an LSU OMS department's chair. \$600,000 was collected, mostly from LSU OMS alumni, and the state matched \$400,000. In 1987, the James R Peltier Chair in Oral and Maxillofacial Surgery was established as the LSU Medical Centers first \$1 Million Chair.

Dr. James Peltier is a Fellow in both the American College and the International College of Dentists. Throughout Jimmy's career, honors were many and appropriate. They included Outstanding Citizenship Award from the city of Thibodeaux, Inaugural Distinguished Service Award from the Louisiana Dental Association, Kennedy Award for Leadership from the Thibodeaux Chamber of Commerce, Outstanding Community Businessman Award from Nicholls State University and LSU Alumnus of the Year in 1995. Highly cherished is the 1994 notification by Arts and Antiques magazine that Jimmy was selected as one of "America's Top 100 Greatest Collectors" for his Jade collection. Finally, LSU awarded Dr. Peltier an honorary doctorate degree, May 16, 2008.

What more can you say about this Tiger. Most importantly, he is a devoted family man. Jimmy married Ann Armstrong in 1952. Their marriage of 68 years is special and enduring. Today Jimmy is a Consultant to all the careers/hobbies he has enjoyed over the past 60 years. They include Oral and Maxillofacial Surgery, Banking, Higher Education, Education Foundations, Camellia Culture, Waterfowl Hunting, Louisianan Saltwater Angling, International Travel, Oriental Art, and Oenology. It has been my privilege to enjoy and profit from the companionship of Dr James Peltier.

JOAN GRECO, DDS, LSU OMS ('94)

Joan has made it her mission to lead a life of personal growth, contribution, and giving back to others. In her 26 years of practice, she is one of 422 female OMS in a field of 6,374 where the average career span of a female surgeon is 15.3 years. She has a thriving practice on the Big Island of Hawaii with offices in Waimea and Hilo with a determination to empower the careers of young women.

Joan attended Dental School at the University of Texas Health Science Center in San Antonio and began her OMS journey with a research fellowship and Internship at Emory University under direction of Bob Bays. She matched at Emory University's OMS program but the program closed. She worked with Mark Fontenot, a close colleague of Dr. Kent, on a TMJ continuous passive motion machine. Mark suggested contacting Dr. Kent for an interview to

complete her OMS training, as there was an opening during the transition of the 4 to 6 year LSU program. Joan was excited, being the second female LSU OMS resident (first being Sloan McDonald '86) in a field of men in a very rigorous program. It was challenging as most recognized her as an equal but a few did not because she was not a first year match at LSU.

"For me, LSU was such an amazing unique program with tremendous volume and the autonomy to do surgeries that wouldn't be allowed elsewhere... I remember saying most days... "This is going to be the time where I am going to learn as much as I can to sustain myself in practice." "It was a unique time because if we found a cosmetic case, we could do it this is where I learned my cosmetic surgery skills (thank you Dale Misiek)." On a one-month rotation at the Institute of Facial Surgery with Dr. Kennedy in Salt Lake, Joan met David Hiranaka, who she later married and they practiced together for 12 years. Even though no longer married, they had two children - Cannon who is a first year Medical Student, and Tori - a graduate of Smith College working with PBS on film documentaries.

Professionally very active, Joan in 2015 was chosen as one of 15 Dental Specialists in North American to be on the Spear Dental Education's Advisory Board, helping to steer its Master's Programs. She remains an active surgery member today on their Ambassador Council overseeing Dental Clinics in Guatemala.

In addition, the JM Greco Foundation supports funding students and focuses on empowering women to show that they and their voices matter. As she has matured in practice and searches for other projects to contribute to, her focus are on several organizations... first being X-Prize. She is on XPRIZE's Innovation Board, a nonprofit organization, which has designed

and operated seventeen competitions in the domain areas of Space, Oceans, Learning, Health, Energy, Environment, Transportation, Safety, and Robotics. X-PRIZE has launched over \$140 million in innovation competition prize purses. Each of these prizes have created industry-changing technology that brings us closer to a better, safer, more sustainable world.

She is also dedicated to an initiative within Xprize called "The Invisible Woman" that is focused on empowering women in business and making sure new products are tested with both women and men in mind. For example, standard crash test dummies used by car companies to test vehicles are designed to represent the impact a crash would have on a man but not a woman..." and this is why women are injured more severely in crashes." Joan, with her involvement with Abundance 360 (a future forward thinking group) is also instigating a paradigm shift in dentistry through AI (artificial intelligence, robotics and nanotechnology). Since she lives on an island in the middle of the Pacific, and it is difficult to find likeminded individuals, she has gotten involved with

the renowned business and life coach - Tony Robbins of which she is proud to be one of his exclusive inner Platinum Partners Lions group, traveling the world several times a year.

"I am so grateful to be living a robust and busy life, none of which would have happened if I first did not get a break from Bob Bays at Emory and then from Jack Kent at LSU. My life is abundant and I give back as I believe giving is living. I gave my donation to the JKOMS Foundation and it is in my will, because without my LSU training I could not have what I have today... to live the way I live, and to share. JOHN PROVENZANO, DDS, LSU OMS ('90)

I completed my residency program in 1990. I proceeded to head home to Wichita, Kansas and start my own practice from the ground up. I quickly developed relationships with general surgeons and an orthodontist from Tennessee. They were all well aware of the reputation of Charity Hospital residents. I was quickly placed on the trauma team and still participate to this day. My practiced blossomed quickly. I performed open TMJ surgeries, arthroscopy cases, and trauma cases. My first orthognathic case was within the first few weeks of opening of my practice. Rigid fixation and multipiece maxillas were foreign words here! I was unaware of how much I learned in residency until I started private practice. My office practice consisted of all aspects of dentalalveoloar surgery and implants. On the downside, I also became aware of the difficulties when dealing with insurance companies. Overtime private practice has changed immensely. I have been able to maintain my autonomous status, continue to

perform orthognathic cases, trauma surgery, dentalalveolar surgery and implants, but the number distribution has changed. My newest endeavor, is becoming a part time employee at the Dole VA in Wichita Kansas. I primarily have done this in remembrance of my father's 25 year military service which included leading the first bombing wave of B-24 Liberators over Normandy beach on D-DAY. He was also an intelligence participant in the Cuban missile crisis. This is my payback.

Personally, the practice of OMFS has allowed me to educate all my children (only one still on the payroll, postgraduate work) and has enabled us to take multiple vacations every year across this great country and abroad. For the past 15 years, we have made regular trips to our Florida beachfront condominium on St. Pete Beach, Florida. I currently go there every three months for a week to rejuvenate myself; no speedo swimsuits allowed. I hope to retire in Florida. However, I may have to move my retirement age to 70-75 since my mother just turned 100 years old on December 23, 2019. My practice has also allowed me to continue my addiction with the automobile, which began before I was driving. I have 12 collectible automobiles ranging from years 1955 -1999. They keep me very busy on the weekends. I love the 50s and 60s cars. I am a gearhead at heart.

As I reflect back on my time at Charity Hospital and the other multiple hospital and clinic rotations, I am dumbfounded on how lucky I was to train at LSU. I feel very blessed that Dr. Kent allowed me into his residency program. I am also very grateful to all the attending staff that contributed to my education. I have represented the LSU OMFS program with pride! In my opinion, the LSU OMFS residency program was still peaking during my years there. This program was second to none, and in this day and age, it will never be replicated.


